

# \$25,000 MEMBERSHIP

SDC's membership dues to support the efforts in creating improvements and opportunities to Highway 85's corridor. Through the efforts of the Theodore Roosevelt Expressway Association, the North Dakota Department of Transportation (NDDOT) is advancing the expansion of US Highway 85 from I-94 to Watford City. Key progress includes completing an Environmental Impact Statement, replacing the Long X Bridge, stabilizing the Horseshoe Bend landslide, and finishing a four-lane stretch from Long X Bridge to Watford City. Work has begun on project development, permitting, and right-ofway planning for segments between ND Highway 200 and Long X Bridge, as well as I-94 to ND Highway 200. A federal grant was secured for the four-lane construction between ND Highway 200 and the Badlands, with bidding set for Fall 2025.


